CHIEF COMMISSIONER'S REPORT

We were greatly honoured when the Honourable Catherine Sidney, daughter of His Excellency the Governor-General, Viscount De L'Isle, V.C., accepted the office of President of our Association. Miss Sidney, who has a Guide background as both Brownie and Guide, has displayed a real and informed interest in our work: for the children, especially, it is a great joy to have as their President someone so close to them in age, and three very excited young proudly people. representing Brownie, Guide and Senior Branches, played their part in the delightfully informal ceremony at Government House, Canberra, when, in the presence of representatives from each of the States, I had the privilege of presenting to Miss Sidney her badge of office.

We acknowledge with gratitude the continued support of the Commonwealth Government; their generous grant has enabled us to continue our special development work in Papua/New Guinea, Nauru, Norfolk Island, the Bass Straits Islands, the Northern Territory, Christmas Island, the Kimberleys in North-Western Australia, and in remote parts of Queensland. As with any work of a developmental nature, the "followup" is of great importance and continues to take top priority in our planning. We regard our annual grant from the Commonwealth Government as recogni tion of the fact that Guiding has some thing of value to offer to girls everywhere, and particularly in remote or newly developing areas, and look upon this as a continual challenge to our resources.

A Conference of Chief Commissioners of Member Countries of the British Commonwealth was held at "Foxlease", England, in July, when representatives from 33 countries met under the chairmanship of Miss Anstice Gibbs, C.B.E. It was a memorable experience to participate and to realise the strength of the bonds which unite these countries, and also to feel that Guiding is able to play some part in maintaining these bonds.

Australian Guiding is, of course, chiefly the co-ordination of Guiding within the various States. As I visit each State it is a continuing joy to see everywhere tangible evidence of the growing strengt! of the Movement. This is most manifest in our chief asset — the young people themselves. Then everywhere new Guide "homes" are appearing, from splendidly efficient Headquarters and Training Centres to simple huts. There seems to be an increased interest in the work of Movements such as ours, and an acknowledgement of the need for the things for which we stand, in particular for Trained Leadership, which Guiding has recognised as essential ever since its inception.

Throughout Australia numbers continue to increase, and now show the impressive total of 110,234; the significance of this figure lies in the fact that our membership is governed by the Guiders available: Packs and Companies are

strictly limited in size, and it is fair to say that if there were more Guiders (adult leaders) there would be many more Brownies, Guides and Senior Branch members; but here lies our chief difficulty: we live in an age when virtually all unmarried women, and a significantly large and growing proportion of married women, work outside the home; therefore the source from which we expect to recruit the majority of our Guiders diminishes as our population increases. Nonetheless, our census shows that no fewer than 7368 women are prepared to give their time and talents, and to undertake the necessary initial and refresher training, in the cause of Guiding; this augurs well for the continued stability and expansion of the Movement, particularly when taken in conjunction with the fact that over 1000 Commissioners, together with many Local Association members and voluntary assistants in other spheres, also give their practical support — all in a voluntary capacity.

With the recognition that more than goodwill is required from the Leaders of our young people, emphasis has again been placed on the Training of Guiders. In additon to the State Advisers we are very fortunate to have a wise and experienced Australian Training Adviser, Miss Clare Broadhurst. She and her Training Committee have earned our gratitude by the great amount of thought and work which they have given to this department

This has not been confined to our own requirements. Once again we have been privileged to send one of our Trainers abroad at the request of the World Association; Miss Margaret Watson, of Victoria, left in April for Korea to carry on the work of the late Miss Gwen Hesketh (Tasmania) in training local Guiders; she broke her forward journey in Hong Kong to test two Guiders for Diplomas, and will again visit Hong Kong on her return journey. Miss Margaret Barr (Victoria) has been selected to leave in July for Ireland, as Australia's representative at the World Association Course for Trainers: here she will be joined by another Australian, Miss Mary Hill (of Tasmania), who has been training for the World Association in Nigeria. Miss Barr also visited New Zealand as guest Trainer in October-November, 1963. We are delighted that

Australia, despite her isolated position in world geography, is thus able to forge new links of friendship with Guiding in distant countries.

Assistance with Training has not been all one way. Australia was most fortunate to have Miss M. Cobham, of England, here for an extended visit, during which she travelled extensively, particularly in Queensland, where she conducted many Training classes in country areas. She also visited Tasmania and Victoria, and her experience and enthusiasm have been of the greatest benefit.

We have been delighted to welcome visitors from many countries: Lady Gibbs, Misses M. Cobham, M. Shanks, Enid White and H. Toft (all from the United Kingdom); Mrs. Charles U. Culmer (retiring President of the Girl Scouts of the U.S.A.); Mrs. Madhuri Ghose (India), Mrs. Usha Phakey (Kenya), Vitenia Cavu (Fiji), Miss Itsi Susaki (Japan), Miss Mary Hopkirk (New Zealand); and a party of Filipino dancers, eight of whom were members of the Movement. We greatly value these visits, and are grateful to our International Commissioner, Miss Dell Hayman, for the manner in which she has brought warmth and informality to our international contacts and correspondence; her extended term of office will conclude at the end of this year, and we thank her for her years of unselfish service, and her wise advice based on a lifetime of Guiding at home and abroad; Miss Hayman will be greatly missed from this office. By coincidence her successor, Mrs. H. Steche, was, like Miss Hayman, a member of Guide Inter national Service: we welcome her to the team, and are delighted that, by a happily-timed trip abroad, she will take over the reins, having made recent contacts with International Commissioners in many countries.

Our Australian Secretary, Miss Lillian Mitchell, M.B.E., represented us in July, 1963, at the International Catholic Guiders' Conference at Vienna; we are grateful to her for the long and detailed preparation she made for this important Conference, and for the wise counsel we have received (and continue to receive) from the Hierarchy of the Roman Catholic Church in Australia.

Miss Mary Lambe, Australian Adviser for the Extension Section, attended a Training in Germany, and the Extension

Australian Guiding was represented, too, at the World Association of Youth Conference, held last December; this was the first occasion on which this Conference had been held in Australia, and our Representative was Miss Julie Hogarth, of South Australia.

Our former members do not forget us, and membership in the Trefoil Guild grows steadily. Service is a watchword, whether it be within the circle of Guiding (as when a guide dog was provided for the blind daughter of a member), or in the community in a multitude of ways. Miss Edith Purnell, Chairman of the Australian Council, attended the Conference of the International Fellowship of Former Scouts and Guides in Rome last July, when 300 delegates from 15 countries discussed the question of Youth in an Age of Leisure. Miss Purnell went armed with a thorough appreciation of the problem in Australia, and brought back much to give us food for thought.

Arising from our Australian Council meeting in April, 1963, we are working to implement a three-year plan for All-Australia events; it is our intention that, in each three-year period, there will be a sequence of Camps, Conferences or Trainings arranged to cover all aspects of Guiding. By means of this plan we hope to avoid duplication of events, at the same time making the best use of our personnel and enlarging the scope of our activities at all levels.

The Australian Executive met in Sydney in June, when, through the courtesy of New South Wales, State Commissioners went into residence at Glengarry Memorial Training Centre for discussions with the Chief Commissioner. As always this lovely bush sanctuary lent a special atmosphere to the Conference: similarly, Kindilan, the Queensland Training Centre, provided a tranquil background for the vigorous discussions of the Diploma'd Guiders at their Training Conference in May.

Brownies have a special celebration this year, for 1964 marks the fiftieth anniversary of this Branch; because Brownies were originally known as "Rosebuds", many Packs have made a feature of roses, either by planting them or by taking them as gifts to hospitals and homes, or to individuals who might be appreciative of a gift of flowers proffered by a bright-faced little girl, celebrating an important birthday by giving rather than receiving gifts.

A particular interest, and one which will continue to be in the forefront of our minds, is the establishment of Sangam, the new Guide International home in India. We are proud that we have already a close tie with this venture by virtue of the fact that Miss Eleanor Manning is a member of the Planning Committee, and was present early in the year at the initial ceremonies at Poona. It is an exciting adventure to be so closely identified with this great enterprise, which will help to forge new ties of

friendship for us with the world and, most particularly, our neighbours in Asia. It is confidently anticipated that "Sangam" will supplement the encouragement and maintenance of international friendship and understanding so evident at our other World Centres in Switzerland, England and Mexico, where Guides from countries all over the world gather together in complete harmony. We are grateful to Mrs. C. O. Fairbairn, O.B.E., and Mrs. H. R. Hancock, who, as Director and Assistant Director of the Appeal Fund, have spurred us on in our efforts to raise a worthy sum for this venture.

Another pleasure has been the constant succession of letters from those who have been given "Ice Cream Doors"; when the Chief Guide was given (at the World Conference in Denmark in 1963) a second "Ice Cream", the hope was expressed that she would use at least part of the sum to provide herself with a tangible remembrance from all those members of the Movement in Australia who had, by forgoing an ice cream, contributed to this special fund; characteristically, however, the Chief decided that from this fund she would give small sums to Guide Houses throughout the world with which she had some special association - perhaps by opening a building, laying a foundation stone, or even walking over a site — and so there came about the "Ice Cream Doors" and an unsought, but greatly valued, contact between Australia and countries overseas; early in 1964 a further small sum was forwarded to Lady Baden-Powell, and it is good to be able to report that, in response to our earnest entreaties, she spent a small part of this on herself that is to say, she bought some plant boxes which are appreciated by the hundreds of visitors who call on her at Hampton Court.

The compact Australian Headquarters has been the scene of many pleasant gatherings, one notable occasion being that of 12th September, when our former Chief Commissioner, Miss Eleanor Manning, O.B.E., was the guest of honour; in the presence of representatives from the States, Mrs. W. C. Wentworth (State Commissioner for New South Wales) formally presented to Miss Manning a handsome bookcase commemorating her term as Chief Com-

missioner. The bookcase is, by Miss Manning's wish, to remain at Head-quarters, and will be a continuing reminder of the significant part she has played in our brief history.

Two deaths at the end of last year touched us deeply: Margery Charlton, M.B.E., and Gwen Hesketh, M.B.E., enriched our Guiding lives by the long years of service they so willingly gave: both served in many capacities, but from Australia's point of view, Mrs. Charlton will be especially remembered for her years as Honorary Australian Treasurer, and Miss Hesketh for her compassionate work in Europe as a member of Guide International Service and her work for Guiding in Korea. In their differen Guiding spheres each had the gift of "looking wide", and we record with gratitude their selfless service and the inspiration of their example.

No report would be possible if it were not for the unceasing efforts of so many people. It is impossible to name them individually, but I hope their sense of achievement and satisfaction will be a reward in itself. I do want to say a very warm "thank you" to all State Commissioners and the members of their Associations who have given me such friendship and made me feel welcome amongst them.

The responsible and often arduous work of the Honorary Treasurer and her Assistant is evident in the financial statements in this Report — as is the splendid support and assistance of our Honorary Auditors, and to them all wexpress our sincere appreciation.

Our Vice-President and Office-Bearers, Liaison Officers and members of Committees have continued to respond cheerfully to every call made on them and have earned our gratitude. Miss Lillian Mitchell, our Secretary, and Miss Kitty Leplastrier meet every possible contingency with ability and a smile, ably assisted by our voluntary helpers in the office, without whose help it is difficult to see how we could carry on. For the loyalty and co-operation and patience of all these people I am most sincerely grateful.



THE GIRL GUIDES **ASSOCIATION AUSTRALIA**

The Australian Council was formed in 1926, and directs a general policy for the Movement within the Commonwealth in matters which affect the State Associations as a whole, and which concern Australia in the international sphere of Guiding — Guiding within the States dates back, in some cases, to the period before the First World War, and each State has autonomy in the management of its own affairs.

Her Excellency Lady Stonehaven, wife of the then Governor-General, was the first Australian President in 1926, and this tradition has been preserved unbroken. It was not until 1948 that a Chief Commissioner was appointed, the position being filled by Mrs. C. O. Fairbairn, who remained in office until 1955, when Miss Eleanor Manning was elected. Her term, with an extension lasted until December, 1962, when Mrs. M. A. Buntine assumed office.

The Council consists of the Chief Commissioner for Australia, who acts as Chairman, all State Commissioners and those Commissioners for Territories who are given the status of State Commissioners by the Council, and not more than two delegates from each State appointed by the respective Executive Committees.
