CHIEF COMMISSIONER'S REPORT



Before presenting our Report for the period 1964-65, and acknowledging with pleasure the support and stimulation we have received from so many sources, I have to record, with deep regret, the great loss the whole Guide Movement has sustained through the death of H.R.H. The Princess Royal. For 45 years years Her Royal Highness was president of the Association, and hers was no token assumption of office — her practical interest in the Movement led her to gatherings of all descriptions; her generous endowment of the Training Centre, "Foxlease", in England helped lay the solid foundations of Guiding as we know it today; and, above all, her inspired, sympathetic interest in the Movement was a consta source of inspiration and strength to

The Guide Movement has been honoured by the acceeptance of the office of President of H.R.H. the Princess Margaret, Countess of Snowdon. Enrolled as a Brownie by her aunt, the Princess Royal, later a Guide and Sea Ranger, Princess Margaret has for many years layed a significant role as Chief Ranger of the British Commonwealth. We welcome her warmly to her new office.

Guiding generally.

The year has seen, too, the loss to Guiding in Australia of our own President, the Hon. Catherine Sidney, now Mrs. John Wilbraham. In this instance, of course, the loss was due to her marriage and subsequent departure for a new home in England, and we rejoice with her in her happiness. During her short term as President, Mrs. Wilbraham won the hearts of all those members of the Mo ment who met her, and with her own background of Guiding, and her youth, she left an impression of charm and efficiency in the discharge of her office. Young members of the Movement were honoured to form a guard of honour for her at her wedding, and it was a great pleasure to me to be present at the subsequent reception at Yarralumla.

With a sense of real regret we have

With a sense of real regret we have seen the resignation from the office of Director of the World Bureau of Dame Leslie Whateley, D.B.E. Dame Leslie came to this appointment soon after the war, when Guiding and Girl Scouting all

over the world was on the point of great expansion. Her background of wide experience, her sympathy with the difficulties of new or struggling Associations, and her practical wisdom, all combined to stimulate Guiding at world level as well as in individual countries. It was a great privilege to Australia to welcome her twice to this country during her years of office. Miss Signe Dreijer, of Sweden, has succeeded her in office, and we are grateful that once again the World Association has as Executive Officer one so eminently well qualified.

My travels have taken me to all States, and I am indeed grateful to those responsible for the planning and carrying at of arrangements concerning my visits. In many cases this has involved a tremendous amount of thought and work, and I can only hope that all taking part in the splendid rallies, conferences and other gatherings have found them as exciting and rewarding as I have done.

I am particularly glad to record that I was able to spend a period in Papua/New Guinea. The progress of Guiding in this territory is of great interest and, I believe, of significant value as a basis for the testing years to come. The training given to girls and young women will, without doubt, stand them in good stead in a society undergoing rapid change. Such training could not be carried through without the sympathetic support and hard work of Territory residents. Australian Guiding as a whole recognises the importance of this particular field, and has consistently given it priority in plan-

We are conscious, too, of our role in such distant territories as Nauru, Norfolk Island and Christmas Island. Great distances emphasise administrative problems, cheerfully tackled and overcome with goodwill on all sides, and Mutual Aid in the Pacific (in which we combine with Great Britain and New Zealand) is always in the forefront of our minds.

In my last Report I mentioned that we had embarked on a three-year plan for All-Australia Conferences and Trainings. This is now well established and promises to be a great strength within the Movement. Our inaugural event under this scheme was the Commisioners' Training, held at Glengarry, New South Wales. The objective was the establishment of a standard of Commissioner training for the whole of Australia, to help Commissioners appreciate their own sphere of

activity thoroughly and, thus trained, to pass on this knowledge to newcomers to the field. The results were encouraging and, although the Commissioners who attended varied considerably in Guiding experience, it was felt that something of value had been gained.

Next came the first All-Australia Lones' Camp, held at Guide House in Victoria. Girls came to this from the four corners of the Commonwealth, many of them enjoying for the first time a gathering of their Guide contemporaries. Their activities were not confined to the camp—many visits and excursions were arranged in and around Melbourne, and the work of the organisers was well repaid when the visitors agreed that they were "Lones, but alone no longer".

The final item for the year in the threeyear plan was an All-Australian Brownie Guiders' Conference/Training held in South Australia. This also was most successful; the pooling of ideas and the widening of experience through various methods of training must be of benefit to Guiding as a whole as well as, obviously, to those who took part.

Twenty-nine of our Trainers attended the Pacific Trainers' Gathering in New Zealand, led by Miss Enid Bunning, of Victoria. Two who were present from New Guinea added an unexpected bonus to their trip — they saw snow for the first time! Several overseas delegates to the Training paused in Australia on their way home, so that we had the pleasure of meeting them, albeit briefly.

In the Extension Section it is a pleasure - I use the word advisedly - to report a slight decrease in numbers. This is due to the fact that handicapped members of the Movement are increasingly becoming members of active units, and these include a number of adults who are working with active Packs and Companies. Indeed our handicapped members are a constant source of inspiration to us. Their latest venture — the culmiation of three years' planning, saving and sheer hard work — was a three weeks' trip to New Zealand for 40 girls and adults, from Victoria, Queensland, New South Wales and South Australia. Of these, 22 were handicapped and 10 were in wheelchairs. Finance for the trip came largely through their own efforts, much of it from the cleaning and sale of used postage stamps. This, in turn, led to a number of interesting contacts with handicapped Brownies, Guides and Rangers overseas, who sent donations of stamps; and since not all the stamps could be disposed of in Australia, many of these are now being sent to Canada, to be used for the benefit of Handicapped Scouts in the under-developed countries. Miss Mary Lambe, our Australian Extension Adviser, led this most successful venture, which began and ended with a 1200 miles flight, and included sightseeing in the North Island as well as camping with New Zealand Extension Guides and Rangers.

Guiding, as we stress, is a Movement which reaches out into the community the little Brownie, busily learning to help in the home; the Guide, acquiring advanced skills so that she may be a useful member of society; and the Senior Branch member, taking these skills out into a wider sphere: all have as a basis of their training the Promise "to help other people at all times". In appropriate cases this is translated as a joint project as with the Churchill Appeal; perhaps in a Company or a District, as in Tasmania, by the joining together of a number of units to support a Korean family. The Fourth Law (a Guide is a friend to all) was again given practical application by the members of a Guide Company in Victoria, who were respon-

sible for bringing a party of 11 Aboriginal children from North Queensland to Geelong to share their summer holiday. In Western Australia the fiftieth anniversary of the Brownie Branch was celebrated, in part, by the raising of money in support of Princess Margaret's Hospital for Children Holiday Camp for needy children. South Australia continues, year after year, to conduct a camp for crippled children in the long school holidays; a community venture of quite a different kind was undertaken by a group of South Australian girls who spent a holiday camping at the Old Timers' Home near Alice Springs. Here they gave practical help both outdoors and indoors, as well as enjoying the boundless hospitality the Centre. Brownies of two New South Wales Packs joined to give happiness to the ladies of the local Eventide Home on Mothers' Day; not only did they bring posies of flowers and plates of afternoon tea to the Home, but they arranged a special entertainment, and each guest was "adopted" for the afternoon by two Brownies. Brownies, Guides and Rangers in the Oueensland town of Beaudesert are partners in a venture which saw its beginnings years ago as a Brownie "Good Turn"; then a party of Extension Brownies from Brisbane was entertained for a weekend by Beaudesert Brownies. With the backing and active co-operation of local residents this visit has become an annual event, with the little Brownies. who so enthusiastically planned the first gathering, now growing up, but still helping in this imaginative scheme.

Perhaps the thoughtfulness, the pr tical kindliness that Guiding engenders, is best summed up in a story from Papua/New Guinea; from time to time Packs and Companies in Australia send small sums of money to be used where needed for Guiding in the Territory. Sometimes this is indeed used within the circle of Guiding, to help provide struggling Companies or Packs with equipment; but often the "Sunshine Fund" as it is called, is used to help individual people in distress — as on a recent occasion when it paid for clothing to outfit a spastic child, so that she could be taken to the Red Cross for treatment. So the ripples spread . . .

Such acts of community service, so vital a part of Guiding, could be multiplied a thousand-fold. The important thing is that they were done joyously, not as a duty, but as a privilege: as a

group of Senior Branch girls said after they had helped man a first-aid station for some days in a bushfire crisis, "We were glad we knew how to help when

help was needed most."

One aspect of our Australian Guiding which unfailingly interests overseas visitors is the session, "Brownies of the Air", conducted in North-Western Australia. Brown Owl and Tawny Owl, the one in Perth and the other hundreds of miles away in Derby (where she conducts meetings through the Royal Flying Doctor Service network) have problems of communication that stagger the imagination — but who could fail to be stirred by the mental picture of the individual Brownies (themselves separated by distance, and perhaps flooded rivers, and certainly by harsh terrain) happily seated at their transceivers in their uniform, attending their Pack meeting?

It is good to report that great strides have been made in the Northern Territory, which is administered by our South Australian Association. Significant of our changing times is the fact that an Aboriginal mother asked for a Company to be started at Roper River, Arnhem Land, and an Aboriginal Company is now established there. Increasingly, members of the Movement are visiting other parts of the continent, attending Trainings or joining other appropriate activities, and this is reflected in the higher standard of Guiding in the Territory generally — several Queen's Certificates have been worked for and won, a notable

xample of achievement.

Many of our members — the majority of them young adults — have taken introductory cards abroad, with the object of meeting Guides in other lands. "Abroad" now has an additional attraction in the nearly completed world home, "Sangam", at Poona, India. Many members of the Movement have already detoured to see "Sangam" in the building stages, and in a more practical way the sum of £5553/16/5, all raised by members of the Movement in this country, has been remitted towards the capital cost of this fourth World Guiding Centre.

Officially we have been represented at Guiding events abroad by several of our members. Our former Chief Commissioner and present Vice-President, Mrs. C. O. Fairbairn, O.B.E., was invited to be guest speaker at the Annual Meeting of Sioux Trails Girl Scouts Council,

(Victoria).

The World Association Conference on Mutual Appreciation of Eastern and Western Cultural Values, held in New Delhi, was attended by Miss Marilyn Gilbertson, of South Australia. Our International Commissioner-Elect, Mrs. Steche, was also able to attend this Conference for a few days as an observer.

As foundation members of the National Youth Council of Australia we were honoured that one of our members — Miss Barbara Neill, of New South Wales — was chosen as Australian delegate to the World Assembly of Youth Conference in the Philippines. Miss Neill visited several countries en route, and was welcomed by the Guide Associations in Singapore, Bangkok, Hong Kong and the Philippines.

Miss Margaret Coleman, Senior Branch Adviser for New South Wales, is representing us at the Round-up at Idaho, U.S.A., together with Senior Branch members, Robyn Riddett and

Trudi Monk, of Victoria. Robyn and Trudi will subsequently break new ground by attending the Jubilee Camp in Jamaica.

We were pleased to welcome home Miss Margaret Watson and Miss Peg Barr, both of Victoria. Miss Watson was absent for some months and conducted Trainings in Korea and Hong Kong. Miss Barr, who was away for a shorter period, represented us at the World Association Course for Trainers in Ireland, together with Miss Mary Hill, of Tasmania, who is still abroad.

As is to be expected in a Movement with strong international affiliations, we have been delighted to welcome many guests from overseas. Particular mention must be made of the visit of Miss Anstice Gibbs, C.B.E., Chief Commissioner for the British Commonwealth, during the spring of 1964. Miss Gibbs came to us in the course of a world tour of Commonwealth countries, and spent sufficiently long with us to visit everv State (including Papua/New Guinea) and the Australian Capital Territory. We are most grateful to her for impetus her presence amongst us has given to Guiding.

We were also happy to welcome Hon. Lady Gibbs, C.B.E., from the United Kingdom; Miss Margaret Bell, International Commissioner for New Zealand; Mrs. C. W. Jackman and Mrs. P. M. Church, of New Zealand, who attended

the All-Australia Commissioners' Training; Miss Joan Quinn, New Zealand representative to the World Association Conference on the Mutual Appreciation of Eastern and Western Cultural Values held in New Delhi; Miss E. Griffiths, of New Zealand; Mrs. van Rooven, Training Adviser, Malayasia, on her return from the Pacific Trainers' Gathering in New Zealand; Miss Marjorie Laurence, Planning Department, Girl Scouts of U.S.A.; Miss A. Shepherd, Girls Scouts of U.S.A., who attended the Pacific Trainers' Gathering in New Zealand, and who is currently based in Japan; M M. A. Potts, former Director of the North Atlantic Girls Scouts of U.S.A.; Mrs. Cluderay, Canada, following the Training in New Zealand.

Links with overseas countries have not been confined to those made by travellers. Through our Post Box over 500 of our members have, during the year, made new pen friends abroad, many with Commonwealth countries, but others, too, in Europe, Scandinavia, the Philippines, Malayasia, Japan and Iceland.

Not only do our members travel extensively overseas — within Australia there is a constant movement of small groups in search of fun and adventure. Perhaps exploring "the Centre" from a chartered bus, digging for gems at Lightning Ridge, roaming round a State in a special train, or taking part in the imaginatively conceived "Heritage Trails" in Tasmania.

Our twin problem, of designing uniforms suitable simultaneously for the tropics and the near-Antarctic, coupled with our appreciation of the fact that costs must be kept at a minimum, have taxed the best endeavours of our cheerfully patient Equipment Secretaries — Mrs. J. K. Proudfoot (Victoria), in the early part of the year, and her successor, Mrs. H. R. Hancock (Queensland).


It is good to report that the Trefoil Guild, which is open to all former active members of the Movement, is increasing not only in membership, but also in the scope of activities. As an example, help has been given to Guides and other children in Papua/New Guinea and to a

hospital in Burma. One Guild entertains the wives of officers of the Tankers which come to their port; another has formed an International Circle which meets once a month, when visitors from other countries are welcomed and many subjects of International interest discussed. Underlying all activities, whether of a Guiding nature or in the community generally, is the spirit of friendliness which is the hallmark of the Movement.

We record with pride that one of our members in Western Australia, Miss Patricia Jeffreys, was awarded a gold medal in the Duke of Edinburgh's Award Scheme for Girls. Patricia, who is 19, worked for two years to fulfil the requirements for this medal, and was the first person in Western Australia to qualify for it.

We acknowledge our indebtedness to so many people — to the Government of Australia, for generous support and encouragement, particularly in the development of Guiding in the Territories and the outback, as well as in our participation in Guiding in the Asian area; to our Honorary Auditors, Messrs. Price, Waterhouse & Co.; and to the host of loyal supporters, whose good counsel and practical help enable us to translate an ideal into reality.

THE GIRL GUIDES **ASSOCIATION** OF AUSTRALIA

The Australian Council was formed in 1926, and directs a general policy for the Movement within the Commonwealth in matters which affect the State Associations as a whole, and which concern Australia in the international sphere of Guiding — Guiding within the States dates back, in some cases, to the period before the First World War, and each State has autonomy in the management of its own affairs.

Her Excellency Lady Stonehaven, wife of the then Governor-General, was the first Australian President in 1926, and this tradition has been preserved unbroken. It was not until 1948 that a Chief Commissioner was appointed, the position being filled by Mrs. C. O. Fairbairn, who remained in office until 1955, when Miss

Eleanor Manning was elected. Her term, with an extension, lasted until December, 1962, when Mrs. M. A. Buntine assumed

The Council consists of the Chief Commissioner for Australia, who acts as Chairman, all State Commissioners and those Commissioners for Territories who are given the status of State Commissioners by the Council, and not more than two delegates from each State appointed by the respective Executive Committees. The Executive Committee comprises the Chief Commissioner, all State Commissioners,

and those Commissioners for Territories who are given the status of State Commissioners by the Council.
